Management Discussion of Fund Performance

Investment Objective and Strategies

The investment objective of the Ninepoint Gold Bullion Fund (the "Fund") is to seek to provide a secure, convenient alternative for investors seeking to hold gold.

As part of its investment strategy, the Fund:

- invests primarily in unencumbered, fully allocated gold bullion and/or permitted gold certificates, the underlying interest of which is gold;
- may invest a portion of its assets in cash, money market instruments and/or treasury bills; and
- may use derivatives, such as currency forward contracts, for hedging purposes only.

Sprott Asset Management LP is the subadvisor for the Fund.

Risk

The risks of investing in the Fund are described in the Fund's simplified prospectus. Direct purchases of gold by the Fund may generate higher transaction and custody costs than other types of investments, which may impact the performance of the Fund. The Fund is suitable for those investors who want exposure to the capital appreciation potential of gold and who want to maintain a high level of liquidity in their investments with a medium to high tolerance for risk and volatility and have a medium to long-term investment horizon.

Results of Operations

The Fund, Series A, returned 9.4% in 2023, versus spot gold, which increased by 10.7% in Canadian dollar terms. In U.S. dollar terms, the spot price increased by 13.1%. The spot price of gold was \$2,062.98/ounce (in U.S. dollar terms) as at December 31, 2023 compared to a price of \$1,824.02/ounce as at December 31, 2022.

In 2023 investors were net sellers of their gold bullion. Typically, money flows dictate the direction of price. The total number of ounces held by gold bullion ETFs declined 8.7%. Bullion ETFs held 93.8M ounces at the beginning of 2023 which declined to 85.6M ounces as 2023 ended. Despite investors dislike for bullion, gold gained 13.1% and new all-time highs were established. The average price of gold through 2023 also registered a new record with the average price rising to \$1,942/ounce versus \$1,802/ounce in 2022. This year was an important year for gold and silver alike for a simple reason. The relationship between investor capital flows and the price metal broke apart as Central Banks continued their torrid pace of bullion acquisitions. While we do not have the final tally for the year, central banks had soaked up almost 800 tons of gold through the first three quarters.

We expect the importance of gold, as an asset class, will continue to improve, given the continuing geopolitical tensions and significant dark clouds gathering around the global economy. The Fund was fully invested in gold bullion during the period.

The Fund's total net asset value increased by 8.6% during the year, from \$167.6 million as at December 31, 2022 to \$182.1 million as at December 31, 2023. This change was predominantly due to net realized and unrealized gains on investments of \$17.6 million, offset by expenses of \$1.6 million and net redemptions of \$1.5 million.

Recent Developments

There were no material changes to the investment strategy and features of the Fund during the year ended December 31, 2023. The Manager actively monitors the positioning of the Fund's portfolio for changes in current market conditions and the economic environment.

Related Party Transactions

MANAGEMENT FEES

The Fund pays a management fee to the Manager at an annual rate of 0.80% for Series A units, 0.50% for Series D and Series F units and as negotiated by the unitholders for Series I. The management fee is calculated and accrued daily based on the daily net asset value of the applicable series of the Fund, and is paid monthly. For the year ended December 31, 2023, the Fund incurred management fees of \$1,226,767 (including taxes). The breakdown of the services received in consideration of the management fees, as a percentage of management fees, is as follows:

Out of the management fees that the Manager received from the Fund, the Manager paid trailer commissions of \$14,939 during the year ended December 31, 2023 to Sightline Wealth Management, an affiliate of the Manager.

OPERATING EXPENSES

The Fund pays its own operating expenses, which include, but are not limited to, audit, legal, custodial, filing and administrative expenses as well as unitholder reporting costs. The Manager pays certain of these expenses on behalf of the Fund and then is reimbursed by the Fund. At its sole discretion, the Manager may waive or absorb a portion of the operating expenses of certain Funds. Amounts waived or absorbed by the Manager are reported in the Statements of Comprehensive Income (Loss). Waivers or absorptions are at the Manager's discretion and can be terminated at any time without notice. During the year ended December 31, 2023, the Manager did not absorb any expenses.

OTHER RELATED PARTY TRANSACTIONS

The Fund relied on the approval, positive recommendation or standing instruction from the Fund's Independent Review Committee with respect to any related party transactions.

2 Management expense ratio ("MER") is based on total expenses (excluding commissions and other portfolio transaction costs) for the stated period and is expressed as an annualized percentage of the daily average net asset value during the period. The Manager may waive or absorb a portion of the operating expenses of the Fund. Waivers and absorption can be terminated at any time.

3 The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period. Since there are no direct trading costs associated with physical bullion trades, the trading expense ratio is nil.

4 The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser trades its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher the Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the Fund.




Past Performance
