Management Discussion of Fund Performance

Investment Objective and Strategies

The objective of Ninepoint Carbon Credit ETF (the "Fund") is to seek to provide unitholders with long-term capital appreciation by investing primarily in global carbon emissions allowance futures. To achieve the Fund's investment objective, the Fund will primarily invest directly in carbon allowance futures. The Fund will initially invest in the major carbon allowance futures globally, namely, the European Union Allowance (the "EUA"), the UK Emissions Allowances Energy (the "UKA"), the California Carbon Allowance (the "CCA") and the Regional Greenhouse Gas Initiative (the "RGGI", collectively with the EUA, the CCA, and the UKA, the "Initial Constituents"). The Portfolio Manager may add or remove constituents that meet or fail to meet the Fund's investment objectives. The Portfolio Manager may change the weighting between constituents in its discretion. The Fund may hold cash or cash equivalents. The Fund may use derivatives and the maximum aggregate exposure to derivatives will not exceed 300% of the Fund's net asset value, calculated on a daily basis.

As part of its investment strategy, the Fund may:

- engage in securities lending as permitted by securities regulations;
- invest in debt securities, cash and/or cash equivalents primarily to meet margin requirements and for cash management purposes; and
- use derivatives instruments, such as options, futures, forward contracts and swaps, for hedging strategies, in a manner which is consistent with the investment objectives of the Fund and as permitted by the Canadian Securities Administrators, including to hedge against losses from changes in the prices of the Fund's investments.

Risks

The risks of investing in the Fund are described in the Fund's simplified prospectus. This Fund is suitable for those investors seeking exposure to global carbon emissions allowance futures. This Fund is suitable for investors with a high tolerance for risk and have a long-term investment horizon.

Results of Operations

The Fund, Series A returned -4.9% in the first half of 2023, while its benchmark, IHSM Global Carbon Index, returned 8.5%.

The first half of 2023 experienced more risk events than normal including multiple major U.S. bank failures, the failure of Credit Suisse and its emergency rescue by UBS, the consistent hiking of interest rates by both North American and European central banks, the official end of China's COVID-19 restrictive lockdown, and the continuation of the Ukraine conflict.

In terms of the compliance/regulatory carbon market, returns have been mixed and volatile. As such, the EUA Dec-23 contract started 2023 at \notin 80, rose to a high of almost \notin 105 in March, fell back to \notin 82 in early June, and stabilized itself at around \notin 90 by the end of June. The UKA started the year at \pounds 73 and rose to \pounds 89 through February before drastically falling to \pounds 49 by mid-year. The CCA opened the year at \$30 and has remained at around this pricing for the first half of the year, while the RGGI's price opened the year at \$14 and has remained in the same range of pricing as well.

The early months of 2023 saw a record-setting warm winter combined with fears of a probable recession due to tighter credit conditions which have been associated with a noticeable lower demand in global carbon markets through a decrease of industrial demand for carbon allowances.

Contrary to some views that the bearish price sentiment would be short lived at the end of 2022, the weakness in carbon allowances pricing (especially for the UKA allowance) has persisted through the first half of 2023, we believe largely as a result of bearish power sector fundamentals.

The current portfolio strategy of the Fund remains in the same format as per its inception, with the Fund invested equally in the four major carbon allowances futures globally (the European Union allowance, the California carbon allowance, the UK allowance and the Regional Greenhouse Gas Initiative), with a minimum quarterly rebalancing.

Despite fears over the past year that a potential global recession could weaken the commitment of government policymakers to greenhouse gas emission targets, the opposite has occurred. Recent increases in carbon taxes in Canada as well as continued tightening of emission targets elsewhere confirms our view that the price of carbon is heading higher over time making this asset class attractive to long term investors. Additionally, it is our belief that the CCA and the RGGI markets are still underpriced, hence why their respective portfolio weight is comparable to those of the UKA and EUA markets in the Fund.

The Fund's net asset value decreased by 13.0% during the period, from \$8.7 million as at December 31, 2022 to \$7.6 million as at June 30, 2023. This change was predominantly due to net redemptions of \$0.8 million, and net realized and unrealized losses on investments of \$0.4 million.

Recent Developments

There were no material changes to the investment strategy and features of the Fund during the period ended June 30, 2023. The Manager actively monitors the positioning of the Fund's portfolio for changes in current market conditions and the economic environment.

Related Party Transactions

MANAGEMENT FEES

The Fund pays a management fee to the Manager at an annual rate of 1.75% for Series A units, 0.75% for Series D, Series F and ETF Series units, 0.65% for Series QF units, 1.55% for Series S units, 0.55% for Series SF units and as negotiated by the unitholders for Series I. The management fee is calculated and accrued daily and is paid monthly based on the daily net asset value of that series of the Fund. For the period ended June 30, 2023, the Fund incurred management fees (including taxes) of \$32,864. The breakdown of the services received in consideration of the management fees, as a percentage of management fees, is as follows:

Out of the management fees that the Manager received from the Fund, the Manager paid trailer commissions of \$562 during the period ended June 30, 2023, to Sightline Wealth Management, an affiliate of the manager.

OPERATING EXPENSES

The Fund pays its own operating expenses, which include, but are not limited to, audit, legal, custodial, filing and administrative expenses as well as shareholder reporting costs. The Manager pays certain of these expenses on behalf of the Fund and then is reimbursed by the Fund. At its sole discretion, the Manager may waive or absorb a portion of the operating expenses of the Fund. Amounts waived or absorbed by the Manager are reported in the Statements of Comprehensive Loss. Waivers or absorptions can be terminated at any time without notice. For the period ended June 30, 2023, the Manager did not absorb expenses.

OTHER RELATED PARTY TRANSACTIONS

The Fund relied on the approval, positive recommendation or standing instruction from the Fund's Independent Review Committee with respect to any related party transactions.

3 The trading expense ratio ("TER") represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period. The TER includes dividend expense and securities borrowing expense paid by the Fund in connection with securities sold short.

The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser trades its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and 4 selling all of the securities in its portfolio once in the course of the year. The higher the portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of the Fund. 5



Past Performance


